#### **POSITION SUMMARY**

The Journeyman Mechanic will perform a wide range of repairs and maintenance on Conservancy vehicles and equipment. The journeyman-level mechanic must have advanced automotive expertise, including engine rebuilding skills. The ideal candidate will be proficient in diagnostics, repairs, and maintenance across a variety of vehicle systems.

### **LOCATION**

This position is based in the interior of Catalina Island in our Middle Ranch auto shop.

### **KEY RESPONSIBILITIES**

- Conduct vehicle diagnostics and analysis to identify issues.
- Perform a wide range of repairs and maintenance on Conservancy vehicles.
- Maintain accurate vehicle maintenance records.
- Ensure equipment availability by inspecting, testing, and performing preventive maintenance, including engine tune-ups, oil changes, fluid checks, tire rotations, wheel balancing, brake repairs, and filter replacements.
- Maintain vehicles in optimal condition by addressing operator concerns, performing inspections, resolving engine failures, repairing mechanical and electrical system malfunctions, and replacing faulty components.
- Change tires using hand tools, pneumatic tools, and a tire-changing machine.
- Record and track all service and repair activities.
- Keep shop equipment operational by following instructions, troubleshooting breakdowns, maintaining supplies, and performing preventive maintenance.
- Stay informed of industry advancements by engaging in educational opportunities and reviewing technical publications.
- Organize work effectively by reviewing daily requirements, gathering necessary supplies, and completing assigned tasks.

- Support Conservancy operations as needed which may include shop cleaning, bison herding, transporting hay, maintaining roads, trimming brush, and participating in fire prevention activities.
- Must work in the office, shop and in the field.
- Must be comfortable working in remote or minimally supervised settings.

# **PHYSICAL REQUIREMENTS**

- Must regularly lift and/or move up to 75 pounds.
- Must have the ability to hike over steep, rugged terrain and on unstable rocky surfaces.
- Position includes extensive manual labor, and use of equipment and tools for up to 8 hours daily.
- Must frequently perform overhead work involving pushing, pulling, and twisting while arms are fully extended (e.g., removing or installing filters, nuts, bolts).
- Must bend, stoop, and lay on the ground to inspect and repair vehicles.
