Eco Tour Adventure Guide

POSITION SUMMARY

The Eco Tour Adventure Guide serves as a primary driver for the Eco Tour Department, leading ecological tours through the Conservancy's interior lands. This role requires expertise in safely operating a tour jeep across challenging terrain while providing guests with an engaging and educational experience. The guide is also responsible for vehicle maintenance, conducting thorough safety inspections, and collaborating on the development of new tour routes and experiences.

LOCATION

This role will be located on Catalina Island. All successful candidates must reside on Catalina Island or be able to relocate.

KEY RESPONSIBILITIES

- Conduct thorough pre-tour and post-tour safety inspections of the vehicle, including checking oil, air pressure, water, and fuel levels.
- Ensure the vehicle is clean, well-maintained, and ready to provide a safe and enjoyable tour experience.
- Contribute to the development of new tour routes and packages by providing field-based insights.
- Engage with guests in a warm, friendly, and professional manner, ensuring a memorable and adventurous experience.
- Complete required forms to provide feedback to management on tour groups.
- Deliver ecological and interpretive excellence as highly informed, well-trained, and sought-after tour leaders, ensuring a positive and lasting impression of the Conservancy.
- Coordinate vehicle maintenance and repairs with Visitor Experience leadership as needed.
- Provide support at the Trailhead Visitor Center as needed, including before, after or between tours.

PHYSICAL REQUIREMENTS

- Ability to walk, hike and work outdoors in difficult and precipitous terrain.
- Must be capable of lifting and carrying up to 50 pounds over rugged terrain.
- Must be comfortable with encountering wild animals, including bison and rattlesnakes.



- Must be comfortable working outdoors in high temperatures and strong wind conditions.
- Maintain a safe and efficient work environment by performing all duties responsibly.
- Promptly address hazardous or potentially unsafe conditions by taking corrective actions and informing the appropriate parties.

PHYSICAL REQUIREMENTS

- Must be able to occasionally lift and/or move up to 25 pounds.
- Ability to hike at least 5 miles over steep and rocky terrain.

- Proven ability to safely operate passenger vehicles in compliance with policies and procedures, with a focus on passenger safety and comfort.
- Strong customer service skills, including the ability to deliver engaging presentations and exceptional experience to guests.
- Excellent oral and written communication skills, including the ability to read road signs, prepare clear reports, and interact effectively with diverse groups, including law enforcement.
- Experience working in various environmental conditions, including extreme weather, dust, and other challenging elements.
- Proven ability to maintain organized and detailed logs, and incident reports utilizing proper grammar and punctuation.
- Knowledge of Catalina Island's natural and cultural history, as well as its ecology, with the ability to interpret and share this heritage effectively with diverse audiences.
- Ability to effectively represent and communicate the organization's mission, values, and goals to inspire and engage stakeholders and the public.
- Flexibility to work weekends, holidays, and overtime as needed.
- Excellent interpersonal skills for building and maintaining positive relationships with colleagues, guests, and the public.
- Must possess a current, valid driver's license held for a minimum of 5 years.
- Commercial driver's license preferred.
- Multilingual skills preferred – Spanish language proficiency is a plus, enhancing the ability to connect with a broad range of visitors.
- Possess a solid understanding of Catalina's ecology.
- Must be able to work overtime/weekends on short notice.

Just off the densely populated Southern California coast, Catalina Island is home to approximately 4,000 year-round residents and more than 60 endemic species of plants and animals found nowhere else on Earth.

The Catalina Island Conservancy protects 88 percent of Catalina Island's approximately 48,000 acres, including the region's longest publicly accessible undeveloped coastline.

The Conservancy is a research and conservation leader, protecting and restoring vulnerable habitats and species in its Mediterranean climate. Conservancy staff guides



Island ecosystem recovery with the goal of generating a resilient, self-sustaining ecosystem with no endangered forms of life.
